

Official Rules & Regulations for the GOLF FOR COPS 2021 RAFFLE

By participating, you agree that:

These Official Rules govern the conduct of the raffle and are binding on everyone who purchases a raffle ticket and/or who is named on a raffle ticket.

This raffle is conducted according to the rules of the State of Florida in accordance with the 2021 Florida Statutes 849.0935.

GOLF FOR COPS 2021 RAFFLE is a fundraising activity in support of The McDavid Group Charities (TMGC) which is a nonprofit corporation, 501(c)(3) charitable organization with a company address of 1 Main Street, Suite 202, Tequesta, FL 33469.

The mission of TMGC is to support through programs the families of fallen law enforcement.

The Prize: Each ticket holder gains entry into the GOLF FOR COPS 2021 RAFFLE.

One Grand Prize winner will be chosen from the ticket holders. The Grand Prize winner will receive a 2021 Street Bob 114 Harley Davidson motorcycle. This is one of H-D's most popular bikes and comes stock with a Milwaukee-Eight 114 engine.

Eligibility: Only persons over 18 years of age and older at time of donation are eligible to participate and enter. - For online purchases, TMGC will provide proof of purchase and ticket stubs at The McDavid Group, LLC office located at 1 Main Street, Suite 202, Tequesta, Florida 33469 on Friday, December 3, 2021, 9:00 am to 3:00 pm (EST) and at Trump National Jupiter, 115 Eagle Tree Terrace, Jupiter, FL 33477 on Sunday, December 5, 2021, 4:00 pm -5:00 pm (EST). You may also receive a photocopy of your tickets via email or text, as directed.
- Tickets and ticket numbers will be assigned in the order that payment is received. All payments will be deposited upon receipt.
- All raffle ticket sales are final.

- TMGC will return any payment received after it has sold 600 tickets or after the deadline(s) stated above.

Selection of Winner:
